NO OTHER AGENCY PROVIDES A PACKAGED, PREPARED MEAL TO THE HOMES OF OUR FRAILEST NEIGHBORS. IN ADDITION TO A NUTRITIOUS READY-TO-EAT MEAL, THE DELIVERY PERSON ALSO OFFERS A SAFETY CHECK TO ENSURE THE WELL-BEING OF OUR CLIENTS EVERY DELIVERY DAY. DURING 2019, THIS PROGRAM DELIVERED 308,636 MEALS TO 2,563 HOMEBOUND RECIPIENTS. INCLUDED IN THIS COUNT ARE 6,875 EMERGENCY SHELF STABLE MEALS FOR OCCASIONS WHEN WE ARE UNABLE TO DELIVER DUE TO SEVERE WEATHER OR UNFORESEEN CIRCUMSTANCES.

THE CHAIR OF THE FINANCE COMMITTEE ALSO INFORMS THE BOARD OF DIRECTORS OF THE COMPLETION OF THE REVIEW AND THAT THE FORM HAS BEEN FILED.
