Dear friends,

As they debarked the Block Island Ferry on a breezy June day, Meals on Wheels of RI team members knew they were experiencing a tremendously exciting moment for our organization.

Delivering our first meals to homebound island residents was a wonderful achievement and illustration of how our strategic work is increasing our statewide impact.

Still, choosing a “best” moment from the past year would be nearly impossible as we are incredibly proud of how your partnership and support has helped us to advance our mission.

In 2023, we continued work to provide clients with social and cultural connections that are proven to improve their emotional wellbeing. Three cultural-specific café dining sites were opened or reopened in 2023, including a monthly luncheon for the Rhode Island older adult Latinx community. We also made our Kosher home-delivered meal menu available statewide, increased community health worker services, and provided additional educational and entertainment opportunities for our Capital City Café Program participants.

As we work to position Meals on Wheels of RI to serve Rhode Island residents at risk of food insecurity and social isolation for generations to come, extension of our “More Than a Meal” service model now includes reaching perinatal women and their families and supplemental grocery delivery to individuals beyond our traditional client populations.


In the year ahead, we will build upon our successes, implement additional initiatives to further extend and expand our work, and drive statewide impact during year two of MOWRI 2025, our strategic plan.

In early 2024, we have completed phase one of a major renovation to our Providence headquarters. Our improved facility will include necessary building updates and creation of additional spaces for programs and initiatives to better serve our client communities.

Later this year, we'll preview a capital campaign that will enable completion of this incredibly impressive project. We hope you will join us in this journey and engage with us throughout the year on many other exciting support opportunities.

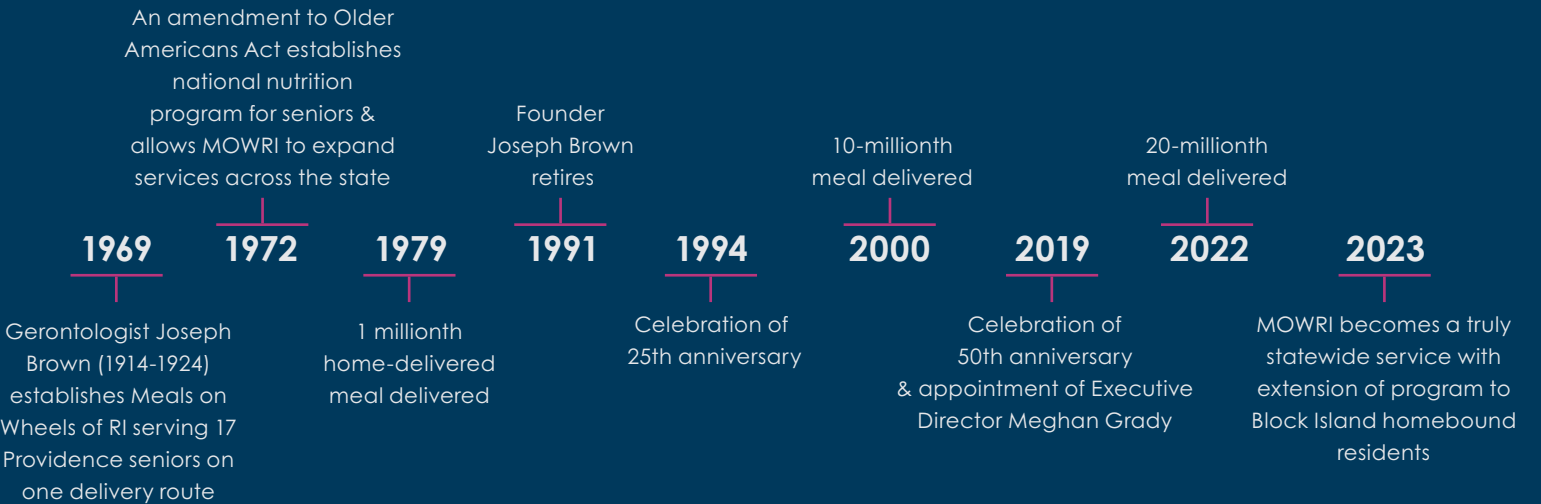

More Than a Meal

Our service model simultaneously addresses our clients' nutritional, safety, and social needs to help them maintain safe and independent lifestyles. Primarily serving older adults since our 1969 founding, we are extending our model to reach additional at-risk populations and increase our statewide impact.

2023 Impact Spotlight

In June 2023, we boarded the ferry in Point Judith and set sail to Block Island to deliver our more than a meal service to homebound older adults in New Shoreham for the first time.

Recognizing the need for our Home-Delivered Meal Program amongst older adults on island, we worked with Town of New Shoreham Director of Human Services Kim Einloth to recruit, train, and dispatch volunteers to deliver meals, safety checks, and social visits to island residents at risk of food insecurity and social isolation.

Within six months, this service extension allowed us to deliver 1,087 meals to 16 homebound Block Island older adults during 2023, and we hope to increase service on island as the need grows.

As a result of this work, we were recognized as the Rhode Island 2023 Community Star by the National Organization of State Offices of Rural Health. This annual recognition honors remarkable individuals and organizations going above and beyond for rural health.



Our Programs & Initiatives

Utilizing our “More Than a Meal” service model, Meals on Wheels of RI programs and supporting initiatives work to reduce food insecurity and social isolation amongst homebound older adults and other at-risk Rhode Island residents statewide.

Home-Delivered Meal Program

Our longest-running program delivers complete and nutritious, fully-prepared meals to homebound Rhode Island residents, 91 percent of whom are older adults. Clients also receive a safety-ensuring wellness check and social visit with each meal delivery.

Pet Food Delivery

We are proud to support clients who depend on their pets for companionship through the delivery of pet food and supplies. We provide this service to homebound clients who need help accessing the resources to adequately care for their pets.

Senior Wish Initiative

This initiative provides clients with gift packages of seasonal essentials, everyday necessities, and other items during the winter holidays thanks to our generous corporate partners and volunteers.

Capital City Café Program

Rhode Island residents aged 60 and older can enjoy socialized dining with their peers at one of our program sites. Lunch programs are held daily in several locations across the City of Providence.

Cultural Cafés

Our monthly cultural café lunches connect clients to their communities with meals and programming designed to meet their specific needs and preferences. We offer luncheons for the older adult Latinx, Southeast Asian, and LGBTQ+ communities. Any older adult Rhode Island resident, aged 60 and older, may participate in these monthly lunches as registered clients of the Capital City Café Program.

Restaurant Dining

We offer Rhode Island older adults aged 60 and older low-cost restaurant dining at participating local eateries. Diners purchase \$5.00 vouchers directly from Meals on Wheels of RI and then exchange the voucher for their meal. Participating restaurants offer diners a choice of meals.

Maternal Health Equity

As an extension of our “More Than a Meal” service model, we offer perinatal women, and their households, home-delivered meals to ensure they are receiving proper nutrition while at risk of food insecurity.

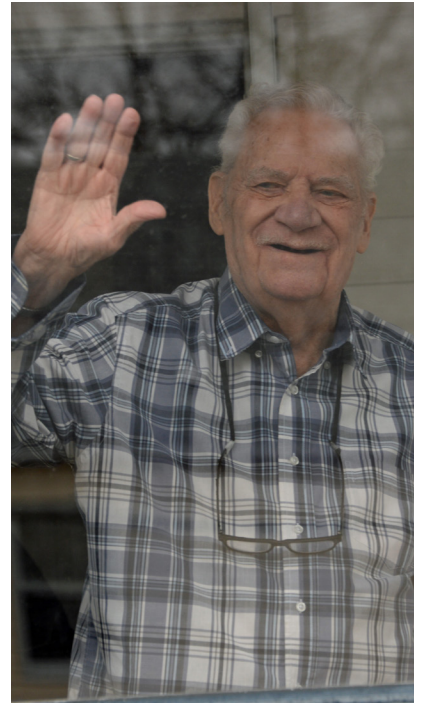
Our food pantry is a resource for older adult Rhode Island residents who may need additional access to food items. The pantry offers a variety of shelf-stable foods, as well as frozen fruits and vegetables, that can be used to make complete and nutritious meals. Our pantry is open weekly and for emergencies.

Supplemental Grocery Delivery

Our Home-Delivered Meal Program clients who cannot access traditional food pantries may request deliveries of shelf-stable food items from our food pantry. Our delivery drivers also identify clients who may need additional foods.

Community Health Work

Certified team members offer our client populations a range of community health worker services.



Home-Delivered Meal Program

Our longest-running program was established in 1969 to help ensure the physical and mental well-being of homebound older adults.

In its first year, the program served 17 Providence clients before growing into a statewide organization. By 1979, the program had delivered one million meals. In 2022, we celebrated the program's 20-millionth home-delivered meal.

Today, we offer home-delivered meals as the only nonprofit meal delivery program of its kind in Rhode Island, serving more than 1,300 clients statewide — including on Block Island — each weekday.

Our drivers bring complete and nutritious, fully-prepared meals to the doors of our clients. Each meal meets one-third of our clients' daily dietary

requirement and includes a protein/entrée, starch and vegetable, as well as a milk or juice and dessert.

Providing much more than a meal, we also ensure client safety through a daily well-being check and work to lessen feelings of isolation and loneliness through the driver visit.

Some client meals are provided through grant and donor funding, including federal and state funds administered by the R.I. Office of Healthy Aging. We also offer a Private Pay program to clients seeking an immediate need for home-delivered meals and for those who may not meet established program eligibility, and we are a provider for several health care plans.



Capital City Café Program

Since the 1990s, Meals on Wheels of Rhode Island's congregate dining "Capital City Café" Program has served older adults who may struggle with adequate nutrition at daily, weekly, and monthly social luncheons.

Our clients enjoy a freshly prepared, multi-course meal, which meets one-third of their daily dietary needs, and the company of their friends in a welcoming, inclusive environment. Guest speakers at café programs regularly provide health education, entertainment, and interactive experiences centered on an older adult's needs and interests.

Throughout its decades of operation, the program has grown in popularity and in 2023 expanded to include two additional culturally responsive monthly cafes for Latinx, Asian, and LGBTQ+ older adult communities.

We are proud that in 2023, this program engaged 545 clients - a 65% increase in attendance over the previous year as we fully reopened our program following the COVID-19 pandemic, increasing our impact on this in-need population.

Mr. Strand's Painting

This past year, we had the great honor of engaging with Mr. William H. Strand, 90, a Home-Delivered Meal Program client who generously shared his life's story with us and our supporters across the state during our 2023 March for Meals campaign. As Mr. Strand became a dear friend to many team members, he also participated in our Festival of Meals fundraiser. While filming with Mr. Strand for an event video, we were inspired by the collection of his paintings hanging throughout his home, including one of the Swamp Meadow Bridge in Foster. We were humbled to offer a framed print of this painting as an auction item at our event, the first time our organization has included a program client's work in our fundraising efforts.

An adored Rhode Island landmark, the Swamp Meadow Bridge was designed and built in honor of Rhode Island's 350th "birthday." It was originally dedicated in May 1993 but destroyed by fire in September 1993. The now-standing bridge was dedicated in November 1994.

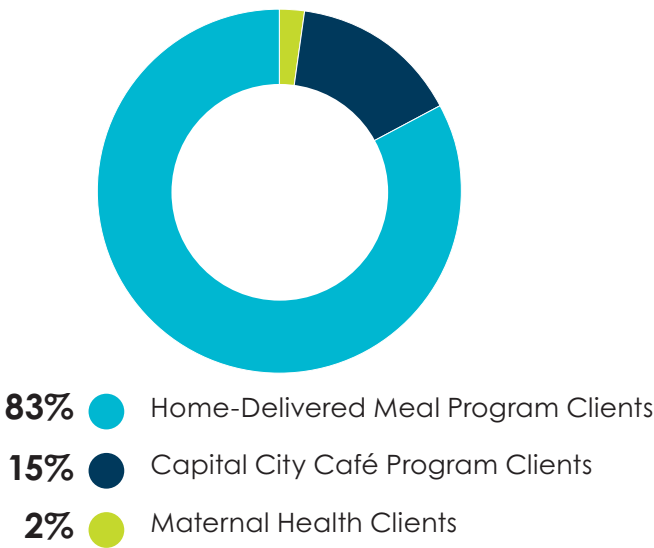

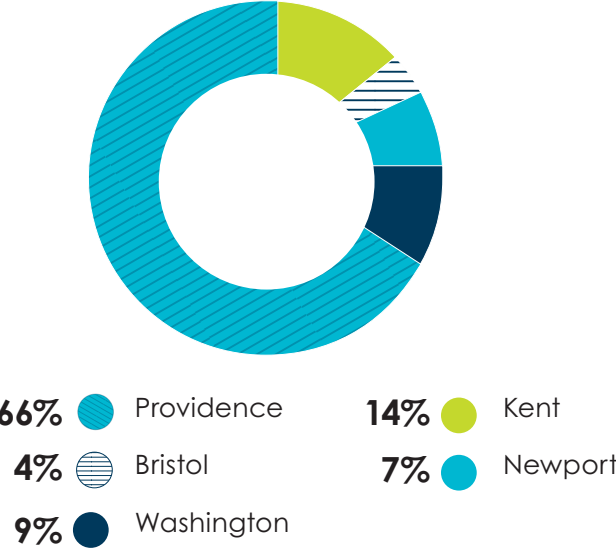

Each year, we invite older adult clients of our Home-Delivered Meal Program to participate in a feedback survey that provides self-assessment of the program's impact on their health and wellness.

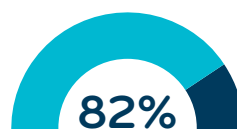
Results of our 2023 survey illustrate the effectiveness of our program and service model.*

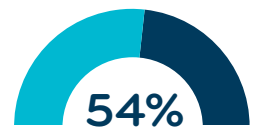
