HOME-DELIVERED MEAL PROGRAM SERVICE ACCOMPLISHMENTS: MEALS ON WHEELS OF RI'S HOME-DELIVERED MEAL PROGRAM IS THE ONLY NONPROFIT HOME-DELIVERED PROGRAM IN RHODE ISLAND THAT OFFERS STATEWIDE SERVICE OF FULLY PREPARED MEALS, WHICH MEET ONE-THIRD OF A SENIOR'S DAILY DIETARY ALLOWANCE, ALONG WITH A SAFETY-ASSURING WELL-BEING CHECK. IN 2024, THIS PROGRAM DELIVERED 269,110 MEALS TO 3,331 HOMEBOUND OLDER ADULTS.

IN 2024, THE ORGANIZATION DELIVERED 120,480 MEALS TO 786 PEOPLE WHO HAVE MEDICAID AND WERE ELIGIBLE FOR A HOME-DELIVERED MEAL BENEFIT.

THE R.I. OFFICE OF HEALTH AGING HAS DIVIDED THE STATE INTO FIVE REGIONS FOR CONGREGATE MEALS; THE ORGANIZATION'S CAPITAL CITY CAF PROGRAM IS THE DESIGNATED PROVIDER FOR THE PROVIDENCE REGION. THIS PROGRAM PROVIDES OLDER ADULTS WHO HAVE AMBULATORY ABILITY WEEKDAY DINING AT SIX COMMUNITY LOCATIONS AND MONTHLY CULTURALLY SPECIFIC SITES FOR THE OLDER ADULT LATIN, SOUTHEAST ASIAN, AND LGBTQ COMMUNITIES. THIS PROGRAM PROVIDED 19,507 MEALS TO 562 RHODE ISLAND SENIORS IN 2024.
